




Fig. 1 - Derating Curve Output Rectified Current




Fig. 2 - Forward Current Derating Curve





Fig. 3 - Forward Power Dissipation





**PACKAGE OUTLINE DIMENSIONS** in millimeters







Fig. 5 - Typical Reverse Characteristics Per Diode
